### Approval of Agenda (6:32pm)

A motion to approve the agenda for the October 26, 2023 board meeting was made by Director Doxey and seconded by Director Ling. The motion was approved unanimously.

# Action Item (6:33pm)

A motion to approve the minutes from the September 21, 2023 board meeting was made by Director Gensler and seconded by Director Ba. The motion was approved unanimously.

## Presidents' Report (6:33pm)

- Discussion to postpone the Board retreat until a full board was in place.
- President Jorgensen also suggested the addition of an item to the board meeting agendas

  School to candidates.By-laws will be consulted and Director Jorgensen will send out information
  to the rest of the board about what the by-laws dictate.

- The Letter of Intent was submitted to Ability Connection Colorado to obtain a new lease for West Campus. No word on the Paris Elementary RFP.
